Willing to be questioned in the Embassy, he refuses to travel to Sweden, as this could lead to his extradition to the USA where it is believed there is a warrant for his arrest on charges of espionage over the release of thousands of documents by the WikiLeaks site. WikiLeaks, founded in 2006, is a legal, non-profit, online news publisher that works with nearly 100 international media organizations and is funded by donations from around the world. WikiLeaks publishes secret and classified information from anonymous, verified news sources and whistleblowers.

WikiLeaks is currently credited with providing to the US public chapters of the secret Trans-Pacific Partnership Trade deal. Based on these leaks, many now believe it is not in the best interests of US workers and country. Assange and WikiLeaks provided protection for whistleblower Edward Snowden, the former computer analyst who leaked NSA documents on mass surveillance and US Government spying to the press.
